Key Focus Areas for Quality Improvement Activity in 2020

- Delivering training on IV Procedure and IV Report Template.
- Consultation with staff when new policies and procedures are developed.
- Further development of QA SharePoint site with access for all staff.
- Engaging with colleagues on the Quality Network around work on the EA National Database.
- Reviewing current assessment procedures with a view towards a locally devised and managed system.
